We are pleased to offer your organization the opportunity for funding from Epiphany Catholic Church in Louisville, KY. The funds we offer represent a portion of a tithe that is set aside from our weekly collections and distributed monthly. Our parish takes pride in our commitment to organizations that work for social justice, help those in need, and empower marginalized people toward improving their life situations.

Each requesting organization is vetted and the application is discussed by Epiphany's 10% Committee. Most funded organizations receive a check for \$1,000-\$1,500. Large organizations with more than a \$2.5 million annual budget will not be considered. We favor smaller organizations for whom our modest grants will create the greatest impact. We ask that each funded organization report on how the grant was used by June 30, 2027.
